3) a) The above persons shall constitute the first Board of Trustees. The trustees shall be competent to Co-opt any person or persons to the Board of trustees for the better maintenance of or the promotion of the image of or for the better administration of the trust. The non-appointment of a Trustee shall not invalidate the Trust or any action taken or done on behalf of the trust. The number of trustees at any time shall not be less than 3 or more than 7.

b) The co-opted trustees shall have a term of three years.

c) If any trustees acts against the objects of the trust or if majority of the trustees are of the opinion that his continuance as a trustee will be detrimental to the interest of the trust, he can be removed or expelled from the trust by the Managing Trustee.

4) The powers of the Board of Trustees are as under:-

i) The trustees shall hold the properties of the Trust for the objects stated herein.

ii) The trustees are entitled to borrow money for the purposes of the Trust with or without security from banks, Financial institutions or others and also have the power to effect any movable or immovable property or other funds of the trust as security.

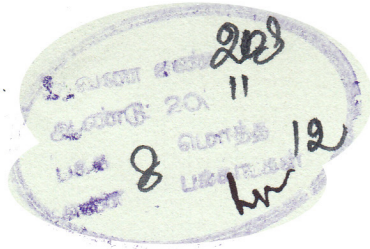
iii) The trustees are entitled to appoint personnel for the purpose of carrying out the objects of the trust and also fix the terms of employment and to dismiss or dispense with the services of such personnel.

iv) The trustees are entitled to appoint Chartered accountants, Legal advisers and such other professionals on such terms as the trustees deem fit from time to time.

v) The trustees are entitled to file suits on behalf of the trust and likewise defend any action taken against the trust and also compromise and compound such cases.

vi) The trustees shall have the power to acquire capital assets for the purposes of the trust and likewise the power to dispose them off.

vii) The trustees are authorised to sell, lease, mortgage or otherwise deal with any of the properties of the trust both movable and immovable as may be found convenient from time to time.

viii) The trustees are authorised to invest the funds of the Trust in accordance with the provisions of the Income Tax Act, 1961 and the Rules made there under from time to time.

ix) The trustees shall not carry on any business with the funds of the Trust.

x) The funds or income of the trust would not be directly or indirectly made available to the Author of the trust or other persons mentioned in Section 13 of the Income tax Act, 1961.

xi) The trustees shall render service to the trust free of charge. Actual expenditure incurred by them for the purposes of the trust may however be reimbursed to them from out of the funds of the trust.

xii) The trustees shall have the power to receive donations or gifts for the trust.

xiii) The board of trustees should meet at least once in six months. Proper minutes book shall be maintained for the meeting of the board of trustees.

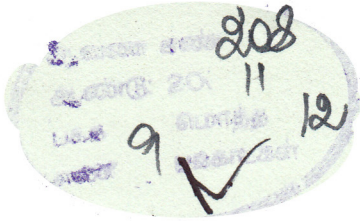
xiv) The trustees are entitled to constitute Committees and to setup Institutions for the purpose of carrying out the objects of the Trust and to dissolve the same at any time.

5) The objects of the Trust are

The main objects of the Trust are

- 1) Development of Education and Educational Facilities
- 2) Eradication of illiteracy.
- 3) To Provide primary education to all
- 4) To promote adult literacy
- 5) Construction and maintenance of community halls, health centers, Schools, hostels, shelters for the poor and downtrodden.
- 6) Poverty eradication
- 7) Eradication of child Labour.

The other Objects of the Trust to achieve the main objects are as under:-

i) To start Nursery, Primary, high schools, Pre-University course, Degree Colleges, including Medical, Engineering Colleges and Polytechnic Colleges

ii) To start training Colleges like, Nursery, D.C.H., B.Ed., B.P.Ed., and Nurse Training and Computer Training Institutions and Driving Schools

iii) To organize health camps, rural water supply, sanitation, environment, protection, ecology in order to uplift the rural and Urban areas.

vi) To improve the Economic Moral and Social standards of Village and Urban areas.

v) To Promote Education, Scheme, Literatures, Fine Arts, Charity and Sports.

vi) To Start and run and maintain Libraries, free reading room for the use among the students or open to public at large.

vii) To open and maintain Hostels for use of poor students.

viii) To serve for the socio-economic development of the poor and needy particularly the disabled.

ix) To provide the basic requirements of food, clothing and shelter along with medicine and medical aid to those who are in need.

x) To extend financial and other assistance to the people who are affected by the natural calamities, communal disturbances, accidents, epidemics, war etc.

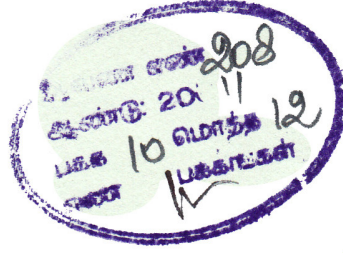
xi) To start, run and support welfare programmes for the poor children, adults and aged and particularly for the sick and disabled.

xii) To collaborate with other organisations having similar objects.

xiii) To do all other incidental and usually necessary things that are needed for the attainment of the above objects.

6) The objects of the Trust shall be carried out only in India.

7) The trustees are authorised to frame rules for the proper conduct and administration of the Trust but any such rule shall not be against the objects of the trust or any other conditions of this trust deed.

8) Audit

The trustees shall maintain proper account of the Trust on an annual basis closing on the 31st day of March every year and prepare income and expenditure statement and Balance sheet and get the accounts audited by a Chartered Accountant

9) The trust is irrevocable and no part of the funds of the trust or income of the trust shall be taken directly or indirectly for the benefit of the author of the trust or of the trustees.

10) It is hereby declared for the removal of doubts that the objects of the trust is not for the benefit of any particular religious community or caste

11) Managing Trustee

R.Sivababishram shall be the first Managing Trustee, who shall hold office till his death, resignation or incapacity

11.1) The managing trustee shall be responsible for the day to day operation of the trust.

11.2) He shall sign all documents, legal papers etc on behalf the trust.

11.3) He shall preside over the trust meetings.

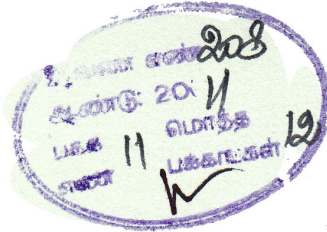
11.4) He shall operate bank account.

12) Each Managing Trustee shall nominate his successor who shall take charge on the death, resignation or incapacity of the Managing Trustee. In case none is nominated the next Managing Trustee shall be elected by the board of Trustees.

13) The Managing Trustee shall exercise all powers of supervision, direction and control of the affairs of the trust generally and be responsible to trustees.

14) The trust can open bank accounts in any bank or banks and such account will be operated by the Managing Trustee or any other person authorized by the board of trustees.

15) It is hereby declared that in the implementation of the objects of the trust or of the conditions of the trust, the decision of the trustees shall be final and cannot be called for into question by any person whatsoever.

16) If for any reason the objects of the trust could not be achieved or for any other reason thought fit by the trustees the trust has to be wound up then the debts and liabilities of the trust shall be first satisfied and the remainder, if any, shall not be divided among the trustees, but shall be transferred to any other Trust Charitable Society or Institution having similar objects and which enjoys exemption u/s 80G.

17) The trustees shall have the power to alter or carryout any ammendment to the trust deed but such ammendment shall not go against the basic character or objects of the trust. Ammendments to the trust shall be carried out only with the prior approval of the Commissioner of Income tax.

18) The trust has no other movable or immovable property except the amount of Rs.1000. The trust is functioning in a rental building.

19) The trust shall apply for PAN, registration under Sec.12A, 35AC, 35(1) (2) and FCRA registration and comply with all legal requirements.


